

PUBLIC NOTICE OF COMBINED CITY & SCHOOL ELECTION
FOR JACKSON COUNTY ON NOVEMBER 5, 2019

PUBLIC NOTICE IS HEREBY GIVEN to all eligible and qualified electors of Jackson County, State of Iowa, that a combined City and School Election shall be held for said County on November 5, 2019. Said election shall be conducted according to Chapters 43, 47, 48, 49, 50, 52, 53 and 56 of the Code of Iowa as amended.

FURTHER PUBLIC NOTICE is hereby given that the following sixteen (16) precincts and polling locations shall be used for said election in addition to the designated absentee polling place. Voters must vote in their precinct and polling place of residence. Please read this notice carefully to determine your correct voting location. Voting locations have changed for some voters to provide consistency in voting locations regardless of election type. Notices were mailed the week of October 14, 2019 to all voters impacted by the changes in voting locations. If you are unsure of your voting location for this election, please contact the Jackson Co. ALL POLLING PLACES in Jackson County are accessible to the disabled person. Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. For further information, please contact the Jackson County Auditor's Office at 563-652-3144 or e-mail at auditor@co.jackson.ia.us. Other necessary accommodations shall be available upon request as required by Federal and State laws.

POLLING PLACE HOURS for the regular sixteen precincts during said election shall be from seven o'clock (7:00) a.m. until eight o'clock (8:00) p.m.

VOTING FOR CITY AND SCHOOL CANDIDATES shall be by use of Unisyn OpenElect Voting equipment. All voters shall vote a paper ballot. An OpenElect Voting Optical Scan, precinct count voting machine, shall be used at said election to cast ballots. An OpenElect Voting Interface, a ballot marking device, shall be available to assist disabled voters.

VOTING MACHINE TESTING shall begin on Wednesday, October 23, 2019 at 9:00 a.m. – 4:00 p.m. and will continue until all machines are tested. The county chairperson of each political party shall be notified in writing of the time said machines shall be examined and tested so that they may be present or have a representative present.

ABSENTEE BALLOTS MAY BE CAST by registered voters through Monday, November 4, 2019 in the Auditor's Office at the Courthouse located at 201 West Platt Street, Maquoketa, Iowa, during regular weekdays from 8:30 a.m. to 4:30 p.m. As an alternative method, upon a submission of a State of Iowa's Official Absentee Request Form, with a written signature, an absentee ballot will be sent by U.S. Mail to the qualified voter. Deadline to request an absentee ballot to be mailed is Friday, October 25, 2019. Deadline for absentee voting in person is Monday, November 4, 2019 by 5:00 p.m. and ballots returned by mail must have a postmark of the same date.

PRE-REGISTERED VOTERS ARE REQUIRED TO PROVIDE an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on election day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by noon on November 12, 2019. Election Day Registrant attestors must provide an approved form of identification. ELECTION DAY REGISTRATION at the polling place for the precinct you currently live in will require proof of residence with a current address in the precinct and identity with a photo ID if you register after Friday, October 25, 2019 pre-registration deadline. You may vote in the Auditor's Office after the voter pre-registration deadline and you will follow the Election Day registration procedure. You will fill out a voter registration form, show your proof of residence and identity, sign an oath and be given an absentee ballot to vote. The best form of ID is a valid Iowa driver's license with current address. Contact the Auditor's Office if more information is needed regarding Election Day Registration.

A bipartisan team will also deliver ballots to a person requesting a ballot in the Jackson County Regional Health Center or a state approved nursing facility during the ten-day period prior to the November 5, 2019 combined City and School Election.

ALL QUALIFIED ELECTORS ARE HEREBY NOTIFIED TO APPEAR AT THE POLLING PRECINCT IN WHICH THEY CURRENTLY RESIDE to cast their ballot for the November 5, 2019 combined City and School Election, during the aforesaid hours and at the aforesaid precinct and polling locations.

"If a majority of eligible electors voting on the question fail to approve this Revenue Purpose Statement, then upon expiration of the current Revenue Purpose Statement, revenues received by the School District from the Secure an Advanced Vision for Education fund shall be expended in the following order:

The payment of bonds for which SAVE Revenue has been pledged;

Reduction of bond levies under Iowa Code Sections 298.18 and 298.18A and all other debt levies;

Reduction of the regular and voter-approved physical plant and equipment levy under Iowa Code Section 298.2;

Reduction of the public educational and recreational levy under Iowa Code Section 300.2;

For any authorized infrastructure purpose of the school district as defined in Iowa Code Section 423F.3(6); and

For the payment of principal and interest on bonds issued under Iowa Code Sections 423E.5 and 423F.4."
