### Purchase Service Contract

### **Update on Current District Projects**

### **Eisenhower Gym Addition Project**

All major framing is complete in the entryway. Work has begun on the plumbing in the kitchen area. Change order #1 for masonry opening supports, sanitary changes, cafeteria flooring, and store front framing in the increased amount of \$136,126.24. Board 07.21.25

Change order #2 for water service entrance changes in the gym portion in the increased amount of \$55,649.49. Board 07.21.25

#### Eisenhower/Keller Roof Replacement

Material has been ordered with the goal of being finished by the time school starts this fall.

# **Irving Mechanical Remodel Project**

All the ceilings are down, and HVAC work continues through classrooms and bathrooms. DNR has been inspecting for asbestos, so work has had to be temporarily shut down this week.

# **Roosevelt Bus Loop Resurfacing Project**

All the concrete and sidewalks are in with resurfacing to take place soon.

Change order #1 for removal and replacement of unsuitable subbase material on walking path for an increased amount of \$53,252.99. Board 07.21.25

Change order #2 for raising existing fire hydrant and replace two existing damaged valve boxes next to hydrant for the increased amount of \$3,425.00. Board 07.21.25

# **Marshall Playground Replacement Project**

Halfway through installing the new equipment. Preschool equipment has been replaced and work on the bigger set has begun.

# **Hempstead Shed Replacement Project**

Rob Powers updated the committee that request for quotes have been received and evaluation of those quotes will begin.

# Cenergistic Update

Josh Pociask updated the committee on his work with dehumidification cycles. Pociask also noted that there has been an over 3 million cost avoidance for the district in the 6 years with Cenergistic.

### Resolution for Items Offered for Sale on Gov Deals

CFO Lisa Demmer reviewed the resolution for sale of four buses that will go out to bid August 5th-26th, 2025 and may be over the \$25,000 limit. If a bid over \$25,000 is received, a public hearing will be scheduled for September 8th, 2025. Board 07.21.25

## Update on Facility Efficiencies

Superintendent Hawkins updated the committee with its continued work with Invision Ar. Petitions are still in the process of being signed and gathered. A traffic study around the Washington Middle School area is taking place and Hawkins noted that she will share with the board the results.
