Children and Electronics

Monitor Their Devices

- Cell Phone
- Xbox, Playstation, Etc..
- Computer

How often are you checking their devices?

- Once a month, twice a month, never?
- What is the passcode (pin, pattern, biometrics, etc)?
- Do you know this passcode?

Who owns the device?

The child or the parent?



Initiate Open Communication

- Tell them you are looking for anything that is inappropriate and/or illegal.
- Let them know that you will be going through their messages.
- What to look for:
 - Child Sex Abuse Material (CSAM) any nude or partially nude photo video or depiction of any person under the age of 18.
 - Drugs
 - Harassment
- Let them know this to protect them, not to get them into trouble.


What platforms are being used?







 - Are there more than two calculators on the device.






Snapchat - My Eyes Only


- Hidden folder inside Snapchat application.

- Password protected by 4-digit PIN code.





Go to Photos




Scroll to down to Utilities – at the bottom

Once this fails twice, you can enter the passcode for the phone to get into the album.



Hidden/Deleted Photos – Apple iPhones


Go to Google Photos

Hidden/Deleted Photos – Google Photos


Androids – Samsung, Motorola, ZTE, Google, Moto G, etc.

- Al generated CSAM

AI Generated CSAM

- This has been taking place as early as 2023.
- Al Generated CSAM has become easier to create due to software programs commonly called Nudify, Undress, or face-swapping apps.
- These apps allow anyone to create fake nudes of children, classmates, famous individuals, etc.
- Most states have now criminalized AI CSAM (lowa is one of these states)
- Technology & Al capabilities are progressing faster than policies & many states don't have frameworks set up in the schools on how to handle child offenders who create or share "deep-fake nudes."

AI Generated CSAM

- In 2023, students at several US middle school and high schools, both public and private, used
 Al to make nudes of classmates.
- States included were New Jersey, Texas, Washington, Florida, Pennsylvania, and California.
- Recently there have been more reports in the media regarding cases in Pennsylvania, Florida, and Iowa. This is also occurring internationally.
- Although this is starting to gain attention it is currently minimal for a country with 54 million school children.
- With that being said we have had at least 4 known incidents involving schools in Dubuque and Western Dubuque school districts ranging from Middle School to High School students



Final tips & takeaways

- Strengthen your familiarity with the applications used by your children. If you don't know what the app is on their phone look it up and **research** it.
- Let your children know this isn't to punish them. This is to protect them.
- Don't get complacent. If you are going to check their devices, keep checking them.
- If your child can't tell you who the person is they are communicating with, then it is not their friend.

* NCMEC introduced "bundling" where a single report can contain multiple incidents – 29.2 Million incidents were reported

Where do we go for help?

- Fastest and quickest way to report an incident is with the local police department or with the Dubuque County Sheriff's Office.
- **NCMEC.org** has all kinds of information related to removing explicit content, Take it Down, completing CyberTip reports, etc.
 - If you complete a CyberTip report it could take months before it gets to the agency who is going to complete the investigation.
 - Take it Down walks through a process to remove explicit images or videos of children shared when they were under 18.

Sexting, Sexual Exploitation of a Child, and the Sex Offender Registry

Definitions

- Disseminate to transfer possession
- Minor any person under the age of 18
- Obscene Material Any material depicting the genitals, sex acts, masturbation, etc. which the average person would find is patently offensive and lacks serious literary, scientific or artistic value
- Prohibited Sexual Act
 - Any actual sex act between two or more persons
 - ▶ Touching of the pubes or genitals of, or by, a minor
 - Nudity of a minor

Definitions

- Promote to procure, manufacture, issue, sell, give, provide, lend, mail, deliver, transfer, transmute, transmit, publish, distribute, circulate, disseminate, present, exhibit, or advertise, or to offer or agree to do any of these acts
 - Long way of saying "provide it to someone else by any means"
- Visual Depiction any picture, slide, photograph, <u>digital or</u> <u>electronic image</u>, negative image, undeveloped film, videotape, <u>digital or electronic recording</u>, live transmission, or other pictorial or three-dimensional representation

Offenses – Sexual Exploitation of a Minor - 728.12(1)

- ▶ Unlawful to employ, use, induce, entice, coerce, solicit, knowingly permit, or otherwise cause or attempt to cause a minor to engage in a prohibited sexual act or in the simulation of a prohibited sexual act, if the act is intended or is photographed, filmed or otherwise preserved in a visual depiction
- Class B Felony 25 years in prison as an adult
- ▶ Tier III Sex Offense
- If you make or cause someone else to make the material

Offenses – Sexual Exploitation of a Minor – 728.12(2)

- Unlawful to knowingly promote any material visually depicting a live performance of a minor engaging in a prohibited sexual act or in the simulation of a prohibited sexual act
- ► Class C Felony 10 years in prison as an adult
- ▶ Tier 2 Sex Offense
- If you give or show the material to someone else

Offenses – Sexual Exploitation of a Minor – 723.12(3)

- Unlawful to knowingly purchase or possess a visual depiction of a minor engaging in a prohibited sexual act or the simulation of a prohibited sexual act
- Class D Felony 5 years in prison as an adult
- Tier 2 Offense
- If you have it
 - Separate charge for each minor depicted
 - Separate charge for each depiction
- Visual depiction includes Al generate images modified to give the appearance that an identifiable minor is engaged in a prohibited sexual act
 - Identifiable minor a person who was a minor at the time the depiction was created OR was a minor in the image used

Offenses – Enticing a Minor – 710.10

- Entice To attract or tempt, often by offering something appealing or desirable, and persuading someone to do something they might not have otherwise done
 - Includes, but not limited to personal contact and communication by any means including mail, telephone, internet, social media, text, messages, instant messages, and electronic mail

Offenses – Enticing a Minor – 710.10(1)

- With the intent to commit sexual exploitation upon a minor under the age of 13, a person entices or attempts to entice a person reasonably believed to be under the age of 13
- Class C Felony 10 years in prison as an adult
- ▶ Tier 3 Sex Offense
- ▶ If you ask a person under 13 for Child Sexual Abuse Material, whether or not they provide it
 - Can be an undercover officer posing as a minor under 13

Offenses – Enticing a Minor – 710.10(2)

- With the intent to commit sexual exploitation upon a minor under the age of 16, a person entices or attempts to entice a person reasonably believed to be under the age of 16
- Class D Felony 5 years in prison as an adult
- Tier 3 Sex Offense
- ▶ If you ask a person under 16 for Child Sexual Abuse Material, whether or not they provide it
 - Can be an undercover officer posing as a minor under 16

Offenses – Harassment in the 1st Degree – 708.7(1)(a)(5)

- Disseminates, publishes, distributes, posts, or causes such, a visual depiction showing another person in a state of full or partial nudity or engaged in a sex act, to which the other person has not consented to the dissemination, publication, distribution, or posting
 - Includes AI generated images
- Aggravated Misdemeanor 2 years as an adult
- Tier 1 Sex Offense
- Sending real or AI generated photos or videos without the other party's consent

Offenses – Dissemination of Obscene Material to Minors – 728.2

- ▶ If 18 or older Sending any obscene material to a minor
- ▶ 1st Offense Serious Misdemeanor 1 year in jail as an adult
- 2nd Offense Aggravated Misdemeanor 2 years in prison, 1 year minimum
- 3rd Offense Class D Felony 5 years in prison 3 year minimum
- ▶ Tier 1 Sex Offense
- ▶ If under 18 and sending to other minors New code 723.2A
- Serious Misdemeanor
- Unsure of Sex Offense Status

Sex Offender Registry

- Separated into 3 tiers
- Registry Requirements
 - ► Appear in Person in the County of Residence
 - Verify Residence, Employment, and Student Attendance
 - ► Provide Photograph
 - Verify Accuracy of Other Relevant Information
- ▶ Tier I Yearly
- ▶ Tier II Every 6 months
- ► Tier III Every 3 months

Sex Offender Registry – Who Must Register

- Any Person Convicted of Any Sex Offense Classified as a Tier I, II, or III
 - Convicted found guilty of, pleads guilty to, is sentenced or is adjudicated delinquent
- When
 - From date placed on probation
 - ► From date of release from prison
 - From date released from a juvenile facility
 - From the date a delinquent starts attending public school
- Registry Required for Adults Convicted

Sex Offender Registry – Who Must Register – Exceptions

- Only Applies to Juveniles Adjudicated Delinquent
- Court Waiver
- Court Modification or Suspension of Registry Requirements
- If the offense if committed by force or threat of violence the court may not waive registry requirements

Sex Offender Registry - Duration

- ► Initial Period 10 years
- ▶ 1st Offense Violation of Sex Offender Registry Additional 10 Years
 - Aggravated Misdemeanor
- 2nd Offense Violation of Sex Offender Registry Lifetime
 - ▶ Class D Felony
- ▶ If placed on the registry as a juvenile, the Juvenile Court will determine whether to remain on the registry when the case closes

Sex Offender Registry – Exclusion Zones

- If on the registry for sex offense against a minor you may not be in the following
 - School Property or within 300 feet Unless enrolled as a student a the school
 - Includes school vehicles
 - No sports participation
 - A Child Care Center or within 300 feet
 - Public Library or within 300 feet
 - Any Place Intended Primarily for the Use of Minors
 - Playground or Play Area
 - Recreational or Sport Area in Use by Minors
 - Swimming Pool or Beach in Use by Minors

Sex Offender Registry – Exclusion Zones – Places of Employment

- Municipal, County, or State Fair or Carnival
- Children's Arcade, Amusement Center (The Fun Station, etc.)
- Elementary or Secondary School, Child Care Facility, Public Library
- Any Place Intended Primarily for Use by Minors
 - Playground or Play Area
 - Swimming Pool or Beach
 - Recreational or Sport-Related Activity Area
- ▶ Ice Cream Truck

Sex Offender Registry – Residency Restrictions

- May not reside within 2,000 feet of school property or a child care facility
- Exceptions
 - Residence established before the school or child care facility
 - ▶ The sex offender is a minor

Court Proceedings

- Adult
 - Warrant and Arrest
 - ▶ Jail and Initial Appearance
 - Records and Proceedings Public
 - Jury Trial
 - ▶ Possible Prison
 - Required Sex Offender Registry

- Juvenile
 - Complaint and Possible Detention
 - ▶ Intake with Juvenile Court Services
 - Subject to Waiver to Adult Court
 - Records Confidential
 - Court Hearings Open to the Public
 - Possible Placements
 - Records Sealable
 - Possible Sex Offender Registry
