Moved (Wittman) and seconded (Sainci) to approve the agenda as submitted. Motion carried 6-0.

Moved (Wittman) and seconded (Sainci) to approve the minutes of the regular meeting of September 8th, 2025, as submitted. Motion carried 6-0.

CFO, Lisa Demmer presented the quarterly budget report.

President Parks gave the Educational Programs/Policy Committee report.

Moved (Sainci) and seconded (Jacobitz-Kizzier) to approve a \$20.00 fine for parking violations on district property. Motion carried 6-0.

Moved (Wittman) and seconded (Bradley) to approve the proclamation for Cyber Security Awareness Month. Motion carried 6-0.
